



## Notification of BT Openreach improvement works - A425 Leamington Road, near Ufton

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty Vinci is working on behalf of HS2 Ltd to build the new railway in your area.

### When where and why the need

We plan to carry out improvement works on the existing BT Openreach overhead assets along sections of A425 Leamington Road and Southam Road in Ufton, as shown on the location plan, overleaf.

The works are planned to be undertaken from Monday 15 August 2022 until Friday 16 September 2022 under a single lane closure. In addition, temporary two-way traffic lights will be in operation from 8:00am until 5:00pm daily, weekdays only.

Works will include the installation of five new ducts crossing the existing road network and three new telecom overhead poles.

These works are required to allow us to safely move plant and machinery into an existing Balfour Beatty Vinci construction site located off Ridgeway Lane and Welsh Road.

### HS2 during the Coronavirus pandemic

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current COVID-19 strategy makes clear that construction activity can continue as long as it complies with this guidance.

The health and safety of our workforce and the communities we affect is our key priority. Please be assured that those sites that are currently still working are doing so because they can operate within Public Health England and construction industry guidelines.

Single lane closure 500 metre north of Dallas Burston Polo Club and Ridgeway Lane, south of Ufton Village Hall.

In addition, temporary two-way traffic lights in operation from 8.00am until 5.00pm daily, weekdays only.

We will be monitoring noise levels at all times.

Continue to keep public safety and that of our workforce as top priority.

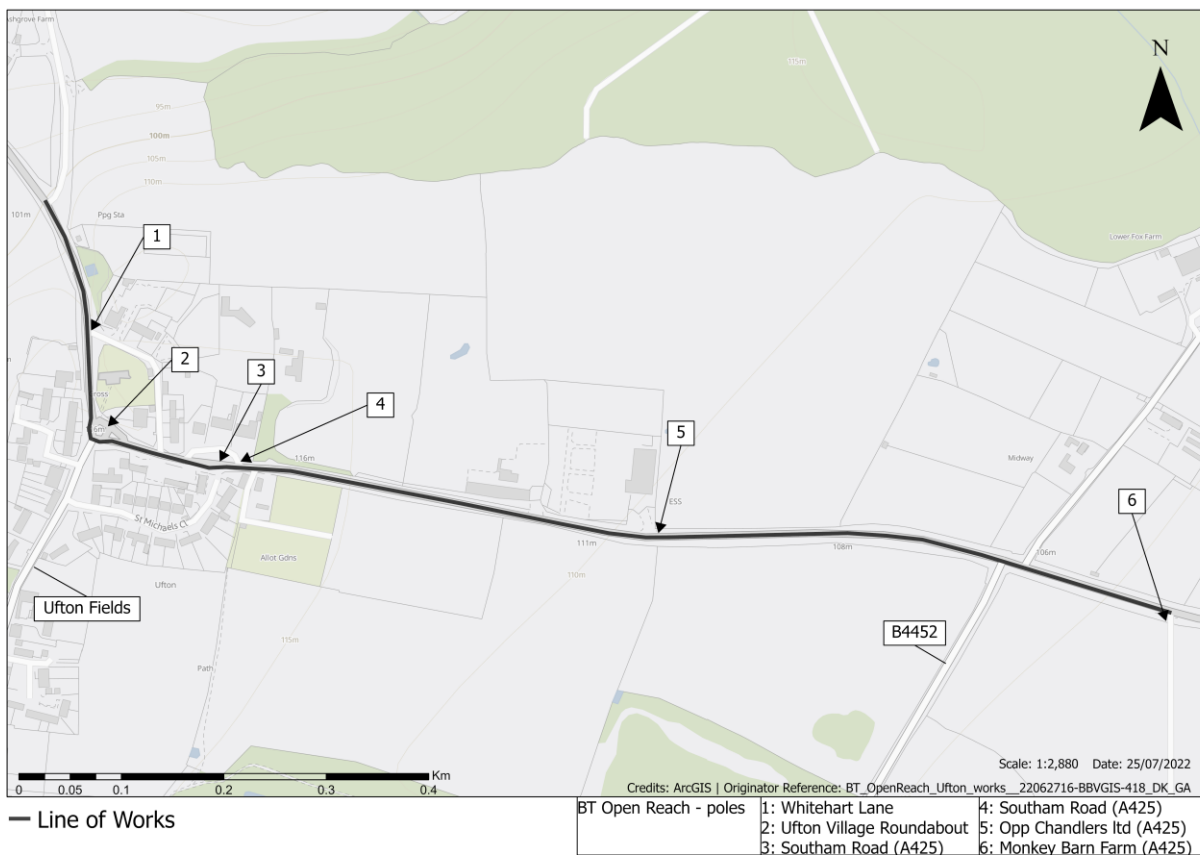
