In this case we have recently been weeding out those items which are out of date, tatty or not issuing at Southam. The timing of this work coincides with our preparations to install self-service machines at Southam and has been done to ensure that we are only "tagging" good condition stock that still has a useful life span. Tagging involves attaching a small chip to the book which will enable the machines to identify it when someone borrows or returns it. Please be assured that Southam, in common with all branches, continues to receive a share of all the new stock that is purchased for the county and a regular turn over of fresh stock from other locations as part of our rotation system.
